Burials on Sunday shall be avoided and shall be permitted in proven emergencies only; additional charges will also be made for this service. All additional charges shall be determined by the Board of Trustees and approved by the State of Cemetery Board. **Additional fee to be \$750.00**

\*\*An additional charge may be made for snow removal or penetration of frost based on the additional costs to the cemetery pursuant to Section 1509 (d) of the not-for-profit corporation law.
